**STATUTES FOR COUNTRY ASSOCIATIONS
ADDENDUM FOR INDIVIDUAL MEMBERSHIP, February 2007**

1. Name and Legal Status

The IAAP is the governing body (within the Medical Section of the School of Spiritual Science) for Individual Members of the IAAP in addition to National Pharmacists Associations and is constituted according to Swiss Law 60 S.1 ZGB.

2. Aims and objectives of the IAAP

In addition to the Aims and Objectives for National Anthroposophic Pharmacists Associations see IAAP, Statutes for Country Associations:

- To enable an Individual Pharmacist to become a member of the IAAP.

It is recognised that in some countries there are few Anthroposophic Pharmacists and therefore it could be difficult for these few to set up a National Anthroposophic Pharmacist Association, or to become a member of an existing IAAP recognised National Association. The IAAP Board has amended the guidelines to permit Individual Anthroposophic Pharmacists to become Individual Members of the IAAP. As a guide a maximum of up to 3 individuals per country will be allowed individual membership of the IAAP. It is felt that if more than this exist, then a national association should be formed in line with the initial impulse for the development of the IAAP.

3. Membership criteria to become an Individual Anthroposophic Pharmacist Member

An individual Anthroposophic Pharmacist has to comply with the following criteria to be recognised as an Individual Member of the IAAP

3.1. Legal Status: Individual Members

- (a) A Pharmacist who has passed all examinations to be recognised as a fully responsible, professional pharmacist. In addition he or she should be registered with a nationally recognised professional pharmacists' association.
- (b) A Member of the Anthroposophic Society or a supporter of the IAAP "Guiding Principles - Extension of the Profession of Pharmacist through Anthroposophy".

(a) The Individual Member must satisfy the defined criteria specifying Anthroposophic pharmaceutical experience and Anthroposophic knowledge/study, as detailed in the Membership Application form. – See Appendix I, and Appendix I.I

(b) must agree to comply with the following procedures:
Complaints and Disciplinary Procedures as detailed in Appendix II

3.2. Legal Status: Honorary Individual Members

Honorary Members – are at the discretion of the IAAP board. They must be elected by a unanimous board decision and they should be few in number.

4. Iaap Board representation for individual members

For every 10 individual members world-wide it is proposed that one will be elected to the IAAP Board of Management as a full participating member. The election shall be arranged by membership secretary (Judith Klahre-Parker) and secretary of the IAAP (Bob Ballard).
